Our Library by Mail service is available to patrons who are unable to come to the library due to illness, disability, or any senior over the age of 80.

We will mail books, DVDs, and audio books (of your choosing) directly to your home with return postage included so you can mail them back!

An application is on the reverse side and can be mailed or faxed to us. If you need a library card issued to you, please make a note on the application and we will issue you a card and mail it with your welcome letter.

For illness or disability under the age of 80, applications must be signed by a health care provider or social services provider.

For seniors over 80 and older, no healthcare provider or social service provider signature is required.

Items may be borrowed for 3 weeks, including processing and delivery time. There are no fines or fee associated with this program.
