he Seminole County's Veterans' Services Office provides assistance to veterans, dependents, and survivors in Seminole County. Veterans Service Counselors are trained service officers who are certified by the Florida Department of Veterans Affairs and are also veterans themselves.

Seminole County veterans can make an appointment with a Veterans Service Counselor or stop by during walk-in hours to go over eligible benefits and receive assistance. During an appointment, expect to spend about an hour with a Veterans Service Counselor in a private office setting. If possible, Counselors can help with filing claims or submitting forms in-office that day.
